Offer Description

Under the terms of article 29-B of the Statute of the Higher Polytechnic Education Teaching Staff Career (ECPDESP), approved by Decree-Law no. 185/81 of July 1, by the text in Decree-Law no. 207/2009, of August 31 (republication), amended by Law n.º 7/2010, of May 13, in conjunction with the ESEP's Regulation for teachers recruitment competition, approved by Dispatch of May 16, 2011, by the President of the Escola Superior de Enfermagem do Porto (ESEP), it is made publicly known that, under Dispatch no. 2023/27, of April 5, by the President of the ESEP, under the competencies foreseen in subparagraph d) of paragraph 1 of article 92 of the RJIES, approved by Law n.º 62/2007, of September 10, and subparagraph g) of paragraph 2 of article 31, of the ESEP Statutes, republished and approved in the annexe to the Legislative Order no. 20/2021, of June 30, published in the Official Portuguese Gazette (Diário da República) 2nd. Series, no. 137, of July 16, 2021, the application is open for a period of thirty business days, starting from the publication of the present Public Notice, for a competition for one vacancy available and not filled in the ESEP's 2023 teaching staff map, under the following terms and conditions:

- 1. Type of competition Documentary application.
- 2. Category Adjunct Professor
- 3. Disciplinary area Nursing (subparagraph a), no. 2 of article 14 of the ESEP's Regulation for Teachers Recruitment Competition.
 - 1. Special selection requirements: Curricular profile in the specific domain of **child health and paediatric nursing** (subparagraph b), no. 2 of article 14 of the ESEP's Regulation for Teachers Recruitment Competition.
- 4. Competition validity The competition is only valid for filling the indicated vacancies and will be extinguished when completely fulfilled or one year after the date of approval of the final classification by the President of the Escola Superior de Enfermagem do Porto. The approved list will not constitute an internal recruitment reserve.

- 5. Functional content As described in paragraph 4 of article 3 of the ECPDESP.
- 6. Workplace Escola Superior de Enfermagem do Porto (pole Cidade do Porto, pole Dona Ana Guedes, and pole São João) and all other facilities where the school develops its activity.
- 7. The remuneration positioning shall be determined in accordance with the provisions of Decree-Law no. 408/89 of November 18, amended by Decree-Law no. 76/96 of June 18, and by Decree-Law no. 212/97 of August 16.
- 8. Admission requisites holder of a PhD degree in nursing or a title of specialist nurse, under the terms of article 17 of ECPDESP.
- 9. Mode of the applicable contractual relationship Employment contract in public functions for an undetermined period of time.
- 10. Detailed application instructions:
 - 1. The application must be presented through a request form, written in Portuguese and addressed to the president of the jury. It must include the candidate's full name, address, telephone number, email address, identification of the job application competition and identification of the attached documents.
 - 2. The request form must be accompanied by the following documents:
 - 1. Detailed curriculum vitae, written in Portuguese and, in the case of candidates from foreign countries, may be written in English, organized exactly according to the parameters and criteria defined in the evaluation grid and published in the competition jury's minutes. It must also be accompanied by the respective supporting documents, presented in the original language in which they were issued, being their translation into Portuguese or English mandatory if they are not written in the original languages;
 - 2. Consent copy of citizen identification documents;
 - 3. A criminal record certificate ensuring that the applicant is not inhibited from holding public office nor is impeded from performing duties related to the application;
 - 4. Certificate of physical fitness and psychological profile required to perform the duties;
 - 5. Updated bulletin with mandatory vaccinations;
 - 6. Authenticated copy of doctoral degree diploma and/or certificate of the title of specialist.
 - 3. The documents mentioned in subparagraphs iii), iv) and v) of the previous paragraph b) can be replaced by a statement under the applicants' oath, which ensures that the applicant is not inhibited from performing public functions or impeded from performing the intended functions, has the physical fitness and psychological profile required to accomplish the duties inherent to the function and has complied with the laws of compulsory vaccination.
 - 4. Applications must be sent by e-mail to rhv@esenf.pt by 11.59 p.m. on the last day of the application deadline.
- 11. Selection and ordering The curricular evaluation of the candidates is materialized in a classification obtained from the application of a valuation system based on parameters, criteria and weightings under article 7 of the ESEP's Regulation for Teachers Recruitment Competition and will necessarily consider:
 - 1. The qualification of the applicant, which will be evaluated based on the assessment of academic and training experience in the specific domain of **child health and paediatric nursing (80 points)**:
 - 1. The academic degrees obtained and the academic exams completed, as well as the exams for the Title of Specialist Nurse, in accordance with Decree-Law 206/2009, of August 31, with the subsequent amendments;
 - 2. Specialized and postgraduate training in the specific domain of **child health and paediatric nursing**;
 - 3. Critical appraisal of the candidate on the relevance of the qualification, and other training, for the performance of the function and its framework in the specific domain of **child** health and paediatric nursing.
 - 2. The applicants' technical-scientific and professional performance will be evaluated based on the assessment of relevant work and activities conducted in the specific domain of **child health and paediatric nursing (50 points)**:
 - 1. Scientific publications in indexed journals;
 - 2. The carrying out of science and technology dissemination;
 - 3. Participation in R&D projects;
 - 4. Participation in juries of academic degrees and other juries;
 - 5. Critical appraisal of the candidate on the relevance of the referred technical-scientific activities for the performance of the function and its framework in the specific domain of

child health and paediatric nursing.

- 3. The applicant's teaching ability will be appraised on the quality and the extent of previous teaching practice, namely (35 points):
 - 1. The total number of teaching hours in curricular units taught and in the different modalities used in the different study cycles; The curricular units taught, regardless of the modalities used in the different study cycles;
 - 2. The experience in producing educational materials and the implementation of techniques and practical methods to support innovative teaching; Tutoring/co-tutoring of academic works at the postgraduate level;
 - 3. Critical appraisal of the candidate on the relevance of the referred pedagogical activities for the performance of the function and its framework in the specific domain of **child health** and paediatric nursing in line with the ESEP's scientific project.
- 4. Other relevant activities under the ESEP's mission, assessed based on the appreciation of the applicant's individual performed activities, namely (35 points):
 - 1. The provision of services and consultancies;
 - 2. The performance of duties and functions in higher education institutions;
 - 3. The performance of duties and functions in healthcare institutions;
 - 4. Professional, social and other activities considered relevant to the School's mission;
 - 5. The elaboration of a scientific-pedagogical project adequate to the functions of the category for which the candidate is applying according to the specific domain of **child health and paediatric nursing** and the ESEP's mission.
- 12. Applicants who obtain a final classification without rounding equal to or higher than 12 points are deemed approved by absolute merit.
- 13. Jury the jury is composed of five elements:

 - 1. Admission of applications After the deadline for submission of applications, the jury verifies the information submitted by applicants, namely, whether the candidate meets the qualification requirements and if all documents that must accompany the application were presented;
 - 2. Hearings of interested parties Applicants who do not meet the eligibility criteria will be excluded from the competition, being previously notified of this intention by e-mail, for the purpose of holding the hearing of interested parties under the Administrative Procedure Code.
 - 3. Public hearings If necessary to clarify aspects of the applicants' curricula, the jury can hold public hearings on equal circumstances for all applicants. These hearings will occur between the 10th and the 20th day following the deadline for submission of applications.

- 4. After the admission applications phase, based on the final evaluation system, the jury will draw up and approve a report of the assessment of the curriculum of each applicant and assigns it a rating on a scale from 0 to 20 (rounded to hundredths).
- 5. Applicants approved with absolute merit are ordered by descending order of the classification obtained as a result of the application of the final valuation system. In case of equal values, the jury will apply tie-breaking criteria previously approved.
- 6. The final ranking list will be published in the official Portuguese gazette (Diário da República), 2nd Series and posted on an appropriate note board at the school and made available on the ESEP's website.
- 7. Consultation process The process can be consulted by applicants who wish to do so, under previous scheduling, at the SGR-RH at the Escola Superior de Enfermagem do Porto headquarters, at Rua Dr. António Bernardino de Almeida, 4200-072 Porto, in business hours, from 10 a.m. to 4 p.m.
